REGISTRATION/ENROLLMENT FEE

Upon the submission of an Enrollment Form, families are asked to include the **registration fee**. Please note that an application will not be considered complete until the registration fee is received. The registration fee may be paid by cheque or online. The registration fee is as follows:

- \$250 - 1st Child
- \$150 - 2nd Child
- \$100 - For every additional child

Early Bird Offer: Enrollment Applications and Fees received by March 31st will receive a discounted Enrollment Fee of \$125/child.

PAYMENT PLANS

Tuition payment plans are offered:

1. Tuition paid in full on or before September 1, 2024.
2. Tuition paid twice annually, half due September 1, 2024 and the remaining half due February 1, 2025.
3. \$1875 Tuition paid in quarterly installments (25%) on: August 1, 2024, October 1, 2024, January 1, 2024, and March 1, 2024
4. Tuition paid in monthly installments with a series of post-dated cheques that are given to the school on or before September 1, 2024 or pre-authorized debit. Subject to a 3% finance fee.

Please inquire about pre-authorized debit if it is preferred to post dated cheques.

TUITION ASSISTANCE

Bursaries and Financial Aid programs are funded by individual donors and various grants support many families to invest in Catholic education. MBCA's Board of Directors is working toward offering tuition assistance as soon as possible. A separate application will be required.

CHARITABLE STATUS - RELIGIOUS EDUCATION ALLOCATION

MBCA is a registered Canadian charity with the CRA for the purpose of religious formation and education. As a charitable organization, MBCA will be able to offer tax receipts for a portion of the paid tuition for the allocation of religious education time.
