SECURING A LOCATION

With the eager interest of families and our expected growth, MBCA has been in search for a property to open the doors of our school as soon as September 2023. With God's grace, an opportunity has been presented in Oakville and our team is taking all necessary steps to move forward for a humble beginning.

LOCATION

St. Aidan's Anglican Church 318 Queen Mary Dr, Oakville, ON L6K 3L6

Centrally located at the corner of Queen Mary Drive and Stewart Street, their facilities include a fully flexible, and accessible main floor space to be divided into smaller combined classrooms in a *Reggio Emilia styled* education. As we prepare to open our doors to humble beginnings for MBCA, our staff and Board of Directors are making it fundamental to ensure the best quality of education and Catholic formation is upheld.

With much collaboration from the administrators of St. Aidan's, our team has been working to stay consistent with our due diligence with Town of Oakville. Through the next 3 months, lease terms and agreements will be negotiated along with applications for a minor variance for parking and a Zoning Occupancy Permit. Upon approval, MBCA will be sharing and opening its admissions process.

START-UP CAMPAIGN
